SUBJECT: -Extension of General Affiliation up to Senior Secondary Level.

Sl. No.	The school is directed to ensure that :
1	The ramp to access upper floor is overlaid over a staircase and is too steep and unsafe for navigation, as seen in the video. The school has a large campus for construction of ramp which has a proper incline. The school shall dismantle the existing ramp and construct a ramp as per norms of RPwD act and guidelines of the Board or install a lift within 3 months and submit compliance on SARAS with videography.
2	The school has shown the fire plan approval certificate to the RC members in lieu of the desired fire safety certificate. Hence the school is directed to obtain valid fire safety certificate and upload the same on SARAS portal within 3 months.
3	The school has converted regular cubicles into CWSN toilets. They are too narrow for a wheelchair/walker to enter and navigate. WCs are placed in correctly in a way which makes them inaccessible for CWSN and render support rods useless. They are not acceptable. The school shall construct separate toilets for CWSN, boys and girls on every floor as per norms of RPwD Act and guidelines issued by the board within 3 months and submit compliance on SARAS with videography.
4	The indoor sports facilities are seen inadequate. Hence the school is directed to upgrade the sports facilities as per SoPs issued by the Board and submit the compliance within 3 months on SARAS portal with videography.
5	The library is seen as under stocked for a higher secondary school. No separate reading area for staff is seen. The school shall upgrade the library as per SoP issued by the Board within 3 months and submit compliance with videography on SARAS.
6	The school shall conduct training of its teachers with CoE Bhopal within 3 months and submit the compliance.

Compliance of the above mentioned points shall be submitted within 03 months on the SARAS Portal. Failure to comply within the prescribed time shall invite financial penalty @ 50,000/- every month until compliance is submitted and shall debar the school from filling the registration and LOC of students class IX to class XII, as the case may be.

5. The school is required to renew mandatory certificates from time to time.
6. The school shall be solely responsible for any legal consequences arising out of the use of school name/logo/society/trust or any other identity /activity related to running of school affiliated to CBSE. All legal expenses incurred by the Board, if any, arising out of these circumstances, shall be borne by the school.
7. The school shall not remove the documents and videography links in the mandatory disclosure section of its website.
8. The school shall follow the SOPs of the Board for its Laboratories, Library and sports facilities issued by the Board vide circular no 11 dated 04.10.2022.

“The school shall possess valid fire safety certificate and Building safety certificate during functioning of the school which shall be renewed from time to time as per norms”.

If the compliance is not submitted within the stipulated 3 months, the Board may enhance the penalty amount and debar the schools from filling up registration/LOC details of students of classes IX to XII, as the case may be, in the next academic session i.e. 2024-25.
